CERTIFICATION AUDITING PROCESS

Optional: Pre-assessment audit

We can provide an independant of your management system (MS) before and/of after the commencement of the Stage 1 audit of the initial assessment process

Stage 1 audit

First, we gain an understanding of your business to assess wether your documented policy, objectives, continual improvement plans and procedures meet the requirements of MS standard. The readiness of your implementation programme is also assessed. (For GDPMDS certification, this audit is combined with stage 2 audit.)

Stage 2 audit

The we audit your MS in action, to check that your declared policy, objectives and targets have been effectively communicated, and that your continual improvement plans and procedures are working in practice.

Certification is then awarded after successful closures of any outstanding issues.

Surveillance audit

After you have achieved certification, we undertake regular ongoing audits of your MS to ensure that it is being maintained and that it continues to meet the objectives of your organisationand the expectation of your customers.

Re-certification audit

The certificate is valid for 3 years. A recertification audit is conducted on the full MS before the expiry of the certificate.
